### 8. Any other competent business:

- Moira reported that Falkirk tenants have been given wet electric heating and they have complained about the costs. Council has been working with Scottish Power and people with high usage will be allocated £450 per year. It was felt that this is unfair as people who live alone would be less likely to get anything back.
- Moira also reported that complaints had been made to Gregor about heating in Crianlarich, mainly from one tenant who wants to change his heating to wood-burning. Tenant has been told he would have to pay for this. Gregor and 2 Income Maximisation Officers had come to the village to discuss heating with anyone interested. As far as Moira knows all went well.
- Rural Stirling's Assurance Statement is on their website. Re. gas servicing if access cannot be gained "we will have no alternative but to cap off your gas supply". Hugh would be unhappy with this happening and surely such action should only be taken as a last resort. Rural Stirling had done a satisfaction survey priorities

were repairs and maintenance. Rural Stirling also do a Good Neighbour Award. All Housing Officers carry out estate walkabouts every month.
